# Community Support in a Challenging Year

In 2020, COVID-19 and the racial justice movement brought a heightened awareness of the impact that can be made through community partnerships and investments.

Whether big cities or small towns, every community we serve was facing the same challenge.

PPL's response to COVID-19 included:

- Significant donations of PPE to local hospitals and emergency management agencies.
- Grants of \$500,000 to assistance programs to help energy customers facing economic hardships.
- Contributions totaling more than \$300,000 in funding to local COVID-19 relief efforts throughout Pennsylvania to support our customers and communities.

Additionally, corporate responsibility staff actively worked with nonprofit partners to facilitate virtual volunteer activities for employees to help communities and individuals hit hardest by COVID-19. Some of the virtual activities included tutoring students in under-resourced schools, sewing masks for healthcare workers and sending cards and letters to older adults isolated in nursing homes.

The racial justice movement of the past year has brought to light the inequities faced by minority citizens in our communities.

While diversity and inclusion have always been key considerations in the choices we make when investing in local communities, the PPL Foundation announced in June 2020 that it would expand the mission and focus to more directly support racial justice and equity initiatives.

The announcement was paired with an initial contribution of \$100,000 to Pennsylvania organizations working to make real and lasting changes in these areas. Additionally, the PPL Foundation launched a scholarship program — Powering a Brighter Future — to advance diversity, equity and inclusion and attract more women and minorities to careers in engineering, information technology, and tech and trade roles. The PPL Foundation will award \$1 million in scholarships over the next decade.

# Illuminating the work of unsung community heroes

In 2020, PPL marked a century of people powering life. To celebrate our centennial, the PPL Foundation honored people who work to transform lives in their communities. They are the **bright lights** powering progress and making a difference.

The PPL Foundation awarded a total of \$100,000 in grants to help illuminate the outstanding contributions of individuals working in the nonprofit sector. Ten Bright Lights grants of \$10,000 were awarded in recognition of the honorees to the nonprofit agencies they support.



Melisa Baez leads the work of ASSETS Lancaster, a nonprofit focused on transforming the community through ethical and inclusive business practices. She has helped countless entrepreneurs start and grow their businesses in Lancaster County and South Central, Pa.



Kristen Boyle is an inspiration to everyone who meets her. Legally blind, she has become an integral part of the design and creation of many programs for Northeast Sight Services in Exeter, Pa. She is committed to the development and improvement of programs that help other members of the community who suffer from vision loss.



#### Dave Brumbaugh, founder and executive director of the Uptown Music Collective in Williamsport, Pa., has spent the last 20 years pursuing one goal – to educate and create well-rounded musicians, ages 10-18, so that they can connect their community with music. "He is not just molding great musicians; he is making great humans," says one student's mom.



Sarah "Sally" Casey has led the struggle against domestic violence in Schuylkill County, Pa., since the grassroots efforts began in 1983. Her dedication and vision ever since to Schuylkill Women in Crisis has developed into a collaborative community response that has helped thousands of victims and their families find safety and healing.

### Powering progress and making a difference



Darian Colbert has invested in the Allentown community by engaging in the leadership development of thousands of students, adult leaders and volunteers through the nonprofit agency, Cohesion Network. Its mission is to collaborate with residents, organizations and local government to empower people socially, educationally and economically, and create lasting change.



**Tim Lee** is the driving force behind **The Mountain Center**, a facility that offers a multitude of services to Monroe County residents. Four years ago, Lee turned an abandoned school building into a community resource center that assisted thousands of Monroe County residents in 2019.



Melissa Fillman founded Kindness is Magic, a Lehigh Valley organization that improves the education outcomes of public-school students by advocating for all students to be provided a nutritious lunch regardless of their economic status.



**Teresa Peters** is making a huge impact in her hometown of Berwick, Pa., and beyond, by operating **For the Cause**, the area's first free, public and youth-led teen center. The nonprofit provides unique programming aimed at developing and supporting teens in grades 7-12. In addition, it offers basic needs such as nutritious food, shelter and clothing.



**Christopher Kaag,** founder and executive director of the **IM ABLE Foundation** in Berks County, Pa., works to promote active lifestyles for everybody, including people with disabilities and veterans.



**Yamelisa Taveras** is the founder of **Unidos**, an organization in the Lehigh Valley that works to improve the quality of life for underprivileged and marginalized residents by empowering unity and self-investment. The group recently raised funds to provide free laptops to Allentown School District students transitioning to remote learning due to COVID-19.

#### **COVID** relief

## United in our mission to help others

As communities and families dealt with the challenges of COVID-19, PPL Corporation and its employees and retirees joined forces to pledge more than \$4.5 million – a record-breaking amount – during the company's annual United Way campaign to help those in need.

The funds are being used to assist families struggling with COVID-19 across central and eastern Pennsylvania; expand educational opportunities for children; support access to health care services, food, shelter and other basic needs; and offer additional assistance that supports healthy communities.
